**WHEREAS:**


The above proceeding was commenced on February 19, 2013, when the petitioner filed a petition for review pursuant to Labor Law § 101 and Part 66 of the Industrial Board of Appeals' Rules of Procedure and Practice (12 NYCRR Part 66) of two orders issued by the respondent Commissioner of Labor against Dennis O'Connor and Bestway Basement LLC on January 14, 2013.


The petition alleges that Bestway Basement LLC did not employ Dennis O'Connor or any of the claimants listed in the orders, that a separate, unrelated business using a similar name employed the claimants, and that Dennis O'Connor was a subcontractor of that other business. By letter dated April 9, 2013, the respondent stated that he agrees with, or can offer no evidence to dispute, the allegations in the petition. Accordingly, the Board grants the petition with respect to Bestway Basement, LLC, and noting that Dennis O'Connor was never properly served with a copy of the orders, revokes the orders with respect to Dennis O'Connor without prejudice.


**NOW, THEREFORE, IT IS HEREBY RESOLVED THAT:**


1. The orders against Bestway Basement, LLC are revoked; and
