RESOLUTION OF APPROVAL

WHEREAS:

1. An application for approval of a proposed certificate of amendment of the certificate of incorporation of the 1199 SEIU/League Grant Corporation was filed with the Board on March 31, 2008, in the above entitled matter; and
2. The proposed certificate of amendment seeks to amend the certificate of incorporation of the 1199 SEIU/League Grant Corporation to change the corporation's name to Healthcare Industry Grant Corporation but otherwise continues the purposes of the 1199 SEIU/League Grant Corporation without change; and
3. The Board previously approved the certificate of incorporation of the 1199 SEIU/League Grant Corporation by Resolution of Approval issued on November 28, 2001; and
4. The Board has made such inquiry into the objectives and purposes of the proposed Healthcare Industry Grant Corporation as it has deemed necessary and advisable; and
5. The Board has given due consideration to all of the papers filed herein and makes the following determinations pursuant to the provisions of Labor Law section 104:

- (a) the stated purposes of the proposed certificate of amendment of the certificate of incorporation of the 1199 SEIU/League Grant Corporation are consistent with public policy and the Labor Law; and
- (b) the proposed name, "Healthcare Industry Grant Corporation," is consistent with the corporation's purposes and not misleading; and
- (c) no further hearing is necessary.

NOW, THEREFORE, IT IS HEREBY RESOLVED THAT:

1. The Certificate of Amendment to the Certificate of Incorporation of 1199 SEIU/League Grant Corporation to change the corporation's name to "Healthcare Industry Grant Corporation" is approved; and
2. A certified copy of this Resolution shall be annexed thereto.
