- 6. By letter dated August 27, 2019, the Board notified Kindya that petitioner must file, within 10 days of the date of the letter, a motion seeking leave to file an untimely petition because petitioner had not complied with the Board's earlier directive and filed an amended petition; and

- 7. By letter dated September 23, 2019, the Board informed Kindya and petitioner that petitioner had failed to provide the required documentation for a complete petition and an explanation as to why the information had not been timely filed as directed by the Board in its August 27, 2019 letter. The letter further stated that if such information was not submitted to the Board by October 3, 2019, the petition would be dismissed; and
- 8. Pursuant to Board Rules § 65.14, "the failure to file any pleading pursuant to these rules when due may . . . constitute a waiver of the right to further participation in the proceeding;" and
- 9. Petitioner has not filed an amended petition or a motion for leave to file an untimely petition; and
- 10. The petition, therefore, must be dismissed for failing to comply with Board Rules § 66.3.

NOW, THEREFORE, IT IS HEREBY RESOLVED THAT:

The petition for review be, and the same hereby is, dismissed in accordance with the Board's Rules.
