
WHEREAS:

NOW, THEREFORE, IT IS HEREBY RESOLVED THAT:


1. The Certificate of Incorporation of "Union Hotel Corfu NY, L.L.C." is approved; and
2. A certified copy of this Resolution be annexed thereto.


